AFFIDAVIT

I, the undersigned,

RICHARD LE ROUX

do hereby make oath and say as follows:

1. I have previously deposed to an affidavit for the Commission on State Capture held in Johannesburg and I have given evidence in relation to same.
2. The facts herein contained are within my own personal knowledge and they are true and correct.
3. Prior to my testimony I accompanied Mr Mlambo, to the various addresses that I testified to in respect of where the special projects team of Sondolo IT (part of the Bosasa/African global group of companies) was run. I was involved in the procurement of the equipment and I also ,together with my team, attended to the installations of the security equipment.
4. I followed the instructions of Mr. Gavin Watson and/or the directors of Bosasa / Sondolo IT.
5. I attended to the addresses for the security installations and after I had done a survey and seen what was required at the various locations, I



then obtained quotes in respect of the required equipment. This was then sent to Mr. Agrizzi for him and the representatives of Bosasa to approve and sign off on.

6. I state further that no installation and/or purchase of equipment could be done without prior approval being obtained.
7. On the 17th of February 2019, I accompanied Mr. Mlambo, on a drive to Port Elizabeth. I then pointed out an address where I and my team had done a security installation. After I identified the location, photographs and video recordings of the equipment that I could recognise were taken.
8. On the 18th of February 2019, in the morning we drove to an address in Green Bushes, Port Elizabeth and photographs and a video recording were taken of some of the equipment including the energizer.
9. On the 19th of February 2019 we drove to a farm in the Elliot area as well as a another address in Cala. We also went past the lodge where myself and my team had stayed while the installations were being done. I did not go into the actual house but I informed Mr. Mlambo where I had done the installations.
10. I am aware that Mr. Mlambo then took photos and videos of some of the installations which I told him I had done at the premises.

11. We then went to Cala and I again stayed in the car while Mr. Mlambo took photographs and a video of the installations that could be seen from the outside.
12. On the 20th of February 2019 we then went to Richards Bay and I took Mr. Mlambo to the house where I had done the installations.
13. I am further in a position to state the location of the premises where I and my special projects team did the installations and further I pointed these out to Mr. Mlambo. I also have knowledge of where the equipment was purchased. This was always done after obtaining prior approval first then it was signed of and I purchased the equipment. I also had a company credit card with a limit in case of emergencies to purchase after I received permission.
14. If I am shown the photographs and video recordings I am in a position to confirm the equipment and the installations.
